- 2. The Procuring Entity shall award the Contracts to one or more suppliers/service providers whose tenders have been determined to be responsive. i.e., Single or Multiple framework contracts will be signed.
- 3. The Procuring entity shall be at liberty to negotiate with successful tenderers before signing of the framework contracts.
- 4. When implementing the framework agreement, KICD will
 - a. procure through call-offs order when necessary; or
 - b. invite mini-competition among persons that have entered into the framework contract.
